Adopted by San Bernardino County voters in 1989, Measure I is the primary source of revenue for transportation improvements in the City of Victorville. This 20-year half-cent sales tax has provided more than \$52 million for Victorville during the first 14 years. Local officials make decisions about the allocation of these funds. In Victorville, 65 percent of the funds are used for regional highways and major streets, 30 percent goes toward local streets and roads, and five percent is used to offset Victor Valley Transit Authority fares for elderly and disabled passengers. Measure I clearly is working for the City of Victorville!

Measure I and Victorville: Progress in Transportation

Of the Measure I funds received each year by Victorville, **65 percent** is used for improvements to city streets that function as major arteries in the region. Some of these regional arterial projects include:

- Widening, construction and rehabilitation of Air Expressway, 1995-2004 (\$4,347,274)
- Design, construction, paving and widening of Mariposa Road, 1990-1997 (\$3,893,172)
- Widening, rehabilitation, signal and drainage of Amargosa Road, 1992-1997, 2003 (\$2,133,155)
- Widening, repaving, signal and off-ramp widening of Bear Valley Road, 1992-2002 (\$2,016,981)
- Traffic signal construction and improvement, various locations, 1995-2004 (\$1,832,994)
- Widening, median construction and rehabilitation of Mojave Drive, 1994-2001 (\$1,739,293)
- Widening and construction of four lanes on Phantom Street, 2003-2004 (\$2,563,152)
- Rehabilitation of National Trails Highway, 1996-1999, 2003-2004 (\$1,437,199)
- Pavement rehabilitation, Civic/Kentwood/Seneca, 2001, 2003-2004 (\$1,437,199)
- Construction and widening of Nisqualli Road, 2001-03 (\$679,948)

Victorville spends **30 percent** of its Measure I funds for improvements to city streets and roads.

Selected projects are:

- Road maintenance, paving, seal coating, striping, overlay and crack sealant, 1991-2004 (\$7,281,916)
- Construction, widening or improvement of various streets: Spring Valley Lake, Nisqualli, Cobalt, D, Bear Valley, Burning Tree, Locust, Lorene, Manzanita, Baldy Mesa, 7th, Green Tree, Pacoima, Enterprise, Francesca, Jade, Shay and Arrowhead, Sycamore 1993-2004 (\$7,482,214)
- Traffic control, signal maintenance and new signal installation, 1994-2004 (\$1,807,566)
- Improvements to Dos Palmas Road, 1997-1999, 2003 (\$402,405)

The remaining **five percent** of Measure I funds are designated for public transit. Victorville supports the Victor Valley Transit Authority with funding for operational expenses. This contribution reduces operating costs, thereby allowing elderly and disabled passengers to ride at lower rates. During the past 14 years, Victorville has contributed \$2,102,973 to VVTA.
