Adopted by San Bernardino County voters in 1989, Measure I is a major source of revenue for transportation improvements in the county’s unincorporated area in the Victor Valley. This 20-year half-cent sales tax has provided nearly \$22 million for this area during the first 16 years. Local officials make decisions about the allocation of these funds. In the Victor Valley, 65 percent of the funds are designated for regional highways and major streets, 30 percent goes toward local streets and roads and five percent is used to offset Victor Valley Transit Authority fares for elderly and disabled passengers. Measure I clearly is working for the Victor Valley!

### Measure I and the Victor Valley: Progress in Transportation

Of the Measure I funds received each year by the San Bernardino County Victor Valley, **65 percent** is used for improvements to streets that function as major arteries in the region. Some of these regional arterial projects have included:

- Reconstruction and realignment of Rock Springs Rd., 1995-2004 (\$1,618,764)
- Bridge replacement and realignment of Indian Trail Rd., 1992-97 (\$1,160,059)
- Improvements to Beekley Rd., 2003-04 (\$1,075,000)
- Widening and asphalt overlay of Stoddard Wells Rd., 1993-96 (\$874,281)
- Rehabilitation, various streets, 2003-06 (\$860,067)
- Pave Summit Valley Rd, SH 138north/Hesperia city limits, 2004-05 (\$847,613)
- Reconstruction and extension of Phelan Rd., 1995-2003 (\$713,419)
- Resurfacing and asphalt overlay of National Trails Hwy., 1992-96 (\$593,871)
- Preliminary design of D St. interchange at Interstate 15, 1997-99 (\$417,000)
- Rehabilitation of Joshua Rd., 2003-04 (\$263,724)
- Signal installation at Sheep Creek and Nielson Rd., 2003-04 (\$233,330)
- Pave Wright Mountain Rd., Zermatt Dr. to SR2, 2005-06 (\$186,501)

The Victor Valley spends **30 percent** of its Measure I funds for improvements to local streets and roads. Selected local projects are:

- Pavement, realignment and signal installation on Beekley Road, 2003-05 (\$2,310,564)
- Improvements to Beekley, Indian Trail, Wagonwheel Trail, Amethyst, Monte Vista, Baldy Mesa, Jenny, Santa Fe and Nielson roads, 2001-06 (\$970,043)
- Resurfacing on various streets, 2003-06 (\$676,528)
- Rehabilitation of various Wrightwood roads, 1994-99, 2002, 2004-06 (\$516,295)
- Asphalt overlay on Luna Road, 1997-2000 (\$335,491)
- Widening and asphalt overlay of Foothill Road, 1993-97 (\$296,437)

The remaining **five percent** of Measure I funds are designated for public transit. The Victor Valley supports the Victor Valley Transit Authority with funding for operational expenses, which allows elderly and disabled passengers to ride at lower rates. During the past 16 years, this area’s contributions have totaled \$913,823.
